CONSTITUTION

ARTICLE I

NAME OF ORGANIZATION

The name of this organization shall be "Tomahawk High School Hatchet Athletic Hall of Fame." It shall be referred to hereinafter as the "Hatchet Athletic Hall of Fame" or "HAHF."

ARTICLE II

PURPOSE

1. To give lasting recognition for outstanding individual contributions to the athletic program of the Tomahawk High School.
2. To help promote greater awareness of the Tomahawk High School athletic program among alumni and especially the "T" Alumni members.
3. To display to the students in attendance at the Tomahawk School, the performance of past athletes who have contributed so much to making the Tomahawk High School a great school.

ARTICLE III

BOARD OF DIRECTORS

Section 1 – Members

- A. The Board shall be the official and governing body concerning all projects, programs, and actions concerned with the Hatchet Athletic Hall of Fame.
- B. The Board shall be responsible for establishing and carrying out all policies and procedures necessary for the proper functioning of the Hatchet Athletic Hall of Fame.
- C. Gender equity will be considered.
- D. The Board shall consist of at least ten (10) members composed as follows:
 1. High School Principal or administrative designee
 2. High School Activities Director or administrative designee
 3. Present Coach
 4. Former Coach
 5. School Board Representative
 6. Media Representative
 7. Booster Club Representative
 8. At least two (2) citizens of the Tomahawk School District
 9. Historian



Section 2 – Terms of Office of Members

- A. Board Members will be allowed to serve unlimited terms. A term will begin with the calendar year. Board inception date is 01/01/2004.
 - 1. High School Principal and Activities Director are default based on their school position.
 - 2. School Board and Booster Club Representative are by volunteer, but must be elected to this Board.
- B. Members will be elected by majority vote of the Board.
- C. The Board will elect an Executive Committee comprising a Chair, Vice Chair, Secretary and Treasurer every three (3) years.
- D. Any elected Board members failing to attend two (2) consecutive Board meetings without providing a good and valid excuse to the Chair or Secretary before the meeting shall be terminated from the Board.
- E. If a vacancy does exist, the Board shall elect a new member at its next regular meeting for the unexpired term.
- F. All terms of office shall start upon election to the Board.

Section 3 – Compensation of Members

All Board members shall serve without compensation of any kind.

**ARTICLE IV
AMENDMENTS**

This Constitution may be amended at any regular meeting of the Board and then only by a two-thirds (2/3) affirmative vote of the ten (10) members of the Board. When possible, notice of any contemplated amendment of the Constitution shall be included in the agenda of a meeting.
